## Event Flow & Rules

### Participation

- Teams must consist of exactly **two members**

## ROUND 1: THE INCEPTION

- Deliver a **3-minute pitch** of your startup concept.
- Followed by a **2-minute Q&A** from the panel.
- Evaluation criteria:
  - Fundamental logic
  - Market viability
  - Passion

## ROUND 2: THE SUDDEN PIVOT

- Teams face a random crisis selected through a “**fish bowl**” method.
- Examples: sudden regulatory bans, lead investor withdrawal, etc.

### 30-Minutes War Room:

- Teams get **30 minutes** to redesign their strategy.

### The Pivot Pitch:

- 3-minute presentation explaining the adaptation.

### Pressure Test:

- 3-minute Q&A with judges.

Only the **Top 5 teams** advance to the final round.

## ROUND 3: THE BOARDROOM DEFENSE

The final five teams enter an intensive Boardroom Simulation.

### 4-Minute Strategy Defense:

- Present the final, crisis-proof business model.

### The Grilling:

- 5 minutes of high-level questioning on:
  - Financials
  - Risk management
  - Sustainability
